

# REGULATIONS FOR THE APPLICATION, ADMISSION, AND PARTICIPATION IN THE ANTI-CORRUPTION IN LOCAL GOVERNANCE TRAINING 2018

# 1 THE TRAINING/PROGRAMME

1.1 <u>General:</u> The Anti-Corruption in Local Governance Training is a standardized training/programme of the International Anti-Corruption Academy (IACA), an international organization with its official seat at Muenchendorfer Strasse 2, 2361 Laxenburg, Austria ("IACA's campus"). The training/programme will run from 09 July 2018 to 13 July 2018. Its structure and content is described at:

- 1.2 <u>Target Group:</u> Local politicians, regional government administrators, municipal leaders, anti-corruption agencies' professionals, experts from ombudsman offices and local anti-corruption organizations as well as governance specialists from development organizations.
- 1.3 <u>Language:</u> The training/programme is administered and will be held in the English language only (translation/interpretation will not be provided).

## 3 APPLICATION



3.1 <u>Application Requirements:</u> Interested professionals (see 1.2 - "Target Group") have to apply personally by **31 May 2018** via the online application form at

https://www.iaca.int/opentrainings/anti-corruption-in-local-governance.html,

- attaching all required documentation, as specified below:
  - a. Curriculum Vitae
  - b. Passport Copy
  - c. 1 Passport Photo
  - d. For trainings/programmes in English: Non-native English speakers have to provide one of the following documents (test scores not older than 2 years):
    - Test of English as a Foreign Language (TOEFL) overall score of: paper-based 574, computer-based 210, internet-based 89.
    - Cambridge First Certificate in English (FCE) corresponding to level B2 of Common European Framework of Reference for Languages (CEFR).
    - Academic IELTS Test overall score of: 6.0.
    - Certificate of completion of at least one year of full time university studies or in a tertiary institution where the language of instruction was English. Proof of professional experience in an English speaking country may be equivalent to such certificate.
    - An academic degree where the language of instruction was English.
  - e. For trainings/programmes in another language than English: Non-native English speakers have to present proof of completion of at least one year of secondary/higher education studies and/or professional experience where the language of instruction/work was [language].
  - f. Optionally in support of the application: Professional references.
- 3.2 <u>Application Process:</u> IACA will confirm the receipt of applications by email. IACA will not process applications and will not return documents sent by postal mail. Incomplete applications will not be considered. Late applications may be considered subject to available places on the training/programme.

Applicants experiencing problems with the online registration are kindly asked to contact IACA for further guidance.

## 4 ADMISSION

4.1 Admissions are at the sole discretion of IACA and not subject to any administrative or judicial review or remedy. Consideration will be given by IACA to criteria, such as the applicant's personal and professional suitability to participate, and a diverse participation in regard of gender, and professional as well as regional background.

- 4.2 IACA may request from applicants additional information/documentation, as well as their availability for interviews.
- 4.3 All applicants will be notified of admission results. Unsuccessful applicants are encouraged to re-apply on another occasion.

# 5 OFFER/ACCEPTANCE

Selected applicants will receive an offer (see 4.3 - "confirmation of acceptance"), to participate in the training/programme. Upon an applicant's written acceptance by the given deadline, his/her participation and these Regulations become binding, including the applicant's obligations of timely payment of the tuition fee, as applicable.

#### 6 PARTICIPATION

Participation in the training/programme shall be conditional on the selected applicant's written acceptance and full and timely payment of all fees, as applicable (see 7.1 and 9.1).

# 7 TUITION FEES / PAYMENT

7.1 Tuition fees, as applicable, are stated at:

- 7.2 Tuition fees are exclusively payable by the deadlines stated on IACA's invoice, and by bank transfer (money wiring) to IACA's bank account.
- 7.3 Payments are effective once accredited to IACA's bank account. Please note that the payment-process may take a couple of days. IACA shall not assume any liability which may arise from the participant's use of any banking and/or online service. Other forms of payment, such as cheque, credit card or cash payments, will not be accepted.
- 7.4 Payments by IACA shall be made only in euros and by bank transfer to the participant's bank account. Any costs or fees associated with the transfer of payments, including but not limited to bank and/or currency conversion charges, are to be borne exclusively by the participant.

# 8 NON-PARTICIPATION/ LATE OR INCOMPLETE PARTICIPATION

No fees shall be refunded by IACA in cases of non-participation, late participation, or incomplete participation. <u>Denied or late visa are not cases of force majeure (see 10.3 - "Visa" and 11.9 - "Legal Matters")!</u>

## 9 CANCELLATIONS



9.1 <u>Cancellation by Participants:</u> Cancellation notices of participants shall be sent to IACA per email to

## Cancellation fees are:

- a. 100 Euro, for cancellations received before 18 June 2018;
- b. 10 % of the tuition fee, for cancellations received between 18 June 2018 and 25 June 2018 inclusive;
- c. 20 % of the tuition fee for cancellations received between 26 June and 2 July 2018 inclusive:
- d. 30 % of the tuition fee for cancellations received on and after 3 July 2018.

Earlier payments by the participant will be accounted for and any surplus returned to the participant.

9.2 <u>Cancellation by IACA</u>: Save cases of *force majeure* paid tuition fees will be fully refunded.

## 10 ADMINISTRATIVE MATTERS

- 10.1 <u>Arrival</u>: The training/programme starts on **09 July 2018** in accordance with the timetable issued by IACA. Participants are requested to arrive on time. Shuttle services will be provided by IACA only at the routes, dates and times set by IACA.
- 10.2 <u>Insurance</u>: Participants are strongly advised to make health and travel insurance arrangements for the duration of the training/programme, including travel. IACA does not make any arrangements or cover any costs relating to travel/health/medical issues (scholarship holders see 12.2 "Scholarships").
- 10.3 <u>Visa</u>: Visa arrangements are at the sole risk and costs of participants, including scholarship holders. Participants are strongly advised to arrange and plan visa early, and inform themselves about the required timeframe. Participants have to apply for the necessary visa with the diplomatic or consular representation of the country of training/programme, well in advance of their planned arrival and at their own costs. For trainings/programmes in Austria: In countries where Austria does not have a diplomatic or consular representation, visa applications can be submitted to the consular authority of another State Party to the Schengen Agreement, acting on behalf of Austria in the country concerned.

PLEASE NOTE: The denial or late issue of visas are not cases of force majeure and do not exempt a participant from his/her payment obligations vis-à-vis IACA.

10.4 <u>Certificates:</u> Upon completion of the training/programme, participants will receive a certificate. In order to obtain the certificate, participants will need to attend all classes, sign the daily attendance sheets.



## 11 LEGAL MATTERS

- 11.1 <u>Copyrights:</u> All materials provided to participants during the training/programme are subject to copyrights and are for each participant's non-commercial and personal use or study only. Any further use, including the reproduction in digital or hard-copy format, requires IACA's authorization. Participants shall not make audio/video recordings during the training/programme. In exceptional cases such recordings may be authorized by IACA.
- 11.2 <u>Use of Personal Data:</u> IACA shall be authorized to store, process and use participants' personal data in connection with its trainings/programmes, including the distribution of their contact details amongst fellow participants of the same training/programme, until a participant's written revocation in accordance with applicable laws.
- 11.3 <u>Personality Rights:</u> IACA may arrange photo/video and/or other recordings during the training/programme and publish them at its discretion. Participants shall respect the privacy of their classmates and refrain from taking photos during the training/programme unless permitted by the persons concerned. Participants shall inform IACA in writing prior the start of the training/programme if they do not wish to be included in photo/videos and/or other recordings arranged by IACA.
- 11.4 <u>Applicable Laws:</u> Participants shall observe all applicable laws and regulations, pertaining to IACA's campus/or another location of training/programme, as well as to the training/programme itself. Furthermore they are subject to local laws during their stay in the training's/programme's location.
- 11.5 <u>Standards of Conduct:</u> Participants are expected to conduct themselves to a standard suitable for professionals in an international academic environment. Any grave breach of these standards, such as cases of harassment, bullying, but also the abuse of alcohol or drugs, may lead to the disqualification of the participant from the training/programme without refund or repayment to IACA of any scholarship, if applicable. Depending on the cause of disqualification, such participants may be temporarily or indefinitely banned from future participation in IACA's programmes or activities.
- 11.6 <u>In-Class Conduct:</u> Freedom of speech and expression are indispensable values of an academic dialogue. Statements or representations made by lecturers and participants are not necessarily shared by IACA. During lectures or other in-class activities the *Chatham House-Rule* applies. All sensitive information shared by participants during the training/programme shall be treated with mutual respect and confidentiality.
- 11.7 <u>Limitation of Liability:</u> IACA's liability for damages shall be limited to cases of gross negligence or willful misconduct on its side, and shall not cover consequential damages. IACA does not assume any liability for damages to or the loss or theft of participants' possessions, including in designated hotels.
- 11.8 <u>Changes to Programme/Regulations:</u> IACA reserves the right to adapt the programme, such as replacing lecturing personnel, schedule, if required for the successful implementation of the training/programme. Any changes to the training/programme or to these regulations will be informed to participants.



11.9 <u>Force Majeure [& other Exceptional Circumstances]:</u> IACA may, at its sole discretion and on a case-by-case basis, evaluate and decide on well-documented cases of *force majeure* (extraordinary events or circumstances beyond either party's control, such as a war, strike, natural disaster or other acts of a similar nature or force), or other exceptional circumstances, such as where the health/safety of the participant him/herself and/or other participants would be endangered.

## 12 SCHOLARSHIPS

12.1 <u>General:</u> Scholarships for the training/programme are offered by IACA for participants from Least Developed Countries (LDCs¹) who have requested such a scholarship with their application and have been selected by IACA on a competitive basis. IACA may request applicants to submit evidence in support of their request for a scholarship.

# 12.2 What is covered: IACA's scholarship covers

- a. a tuition fee waiver;
- b. travel between the airport near the scholarship holder's residence or other location designated by IACA, and the location of the training/programme;
- c. accommodation, and transfer services, and shuttle services between the location of training/programme and the designated hotel, as detailed under 12.4 "Booking Arrangements/Standards";
- d. arranging reasonable travel health insurance coverage for the duration of the training/programme; apart from this insurance fee, <u>IACA shall not bear any costs or assume any liabilities in respect of medical requirements of a scholarship holder</u>.
- 12.3 <u>Prohibition of Double-Funding</u>: Scholarship holders warrant that they have not received and will not receive in the future any financial support by a third party pertaining to their participation in the training/programme and covered by IACA's scholarship. They undertake to immediately report to IACA any such support granted to them and to refund to IACA any such amount received.
- 12.4 <u>Booking Arrangements/Standards</u>: Arrangements/Bookings for travel (round-trip, including luggage, as detailed for the specific travel), transfer, shuttle services, and accommodation (night/breakfast) are made exclusively by IACA and at the most cost-effective economy/budget rates, standards, and dates. That may entail earlier/later arrival/departure as well as stopovers during travel. Any costs for additional services, such as utility charges, extra-luggage/weight, telephone or internet, minibar-consumption, are not covered by IACA. Any other arrangements/bookings other than at the most cost-effective economy/budget rates, standards, and dates, including re-bookings/change of itinerary, will only be made by IACA for imminent and unforeseeable reasons and on a written request of

the scholarship holder. All costs of such adaptations shall be borne by the scholarship holder.

- No-Shows/Non-Participation/Incomplete Participation or Late Participation: Due to the commitments of funding by IACA, scholarship holders are to participate in the full training/programme. In cases of no-shows, non-participation, incomplete participation, or late participation, the scholarship holder shall pay to IACA the following fees:
  - a. 1,000 Euro in cases of non-participation and/or no-shows, and additionally costs incurred by IACA due to the non-participation and/or no-shows;
  - b. 100 Euro for each day of absence in cases of incomplete participation.
- 12.6 <u>Cancellation by Scholarship Holders/Reimbursement of Costs:</u> Cancellations by scholarship holders shall only become effective, if sent personally to IACA in writing to <u>localgovernance@iaca.int</u> and upon receipt by IACA. Scholarship holders, who cancel their participation in the training/programme, shall reimburse and hold IACA harmless for all costs and liabilities, including for travel and accommodation costs, incurred by IACA until the receipt of the respective cancellation notice.

<u>Denied or late visa issues are not cases of force majeure or exceptional circumstances that will be reviewed by IACA (see 11.9 - "Legal Matters" and 10.3 - "Visa").</u>
